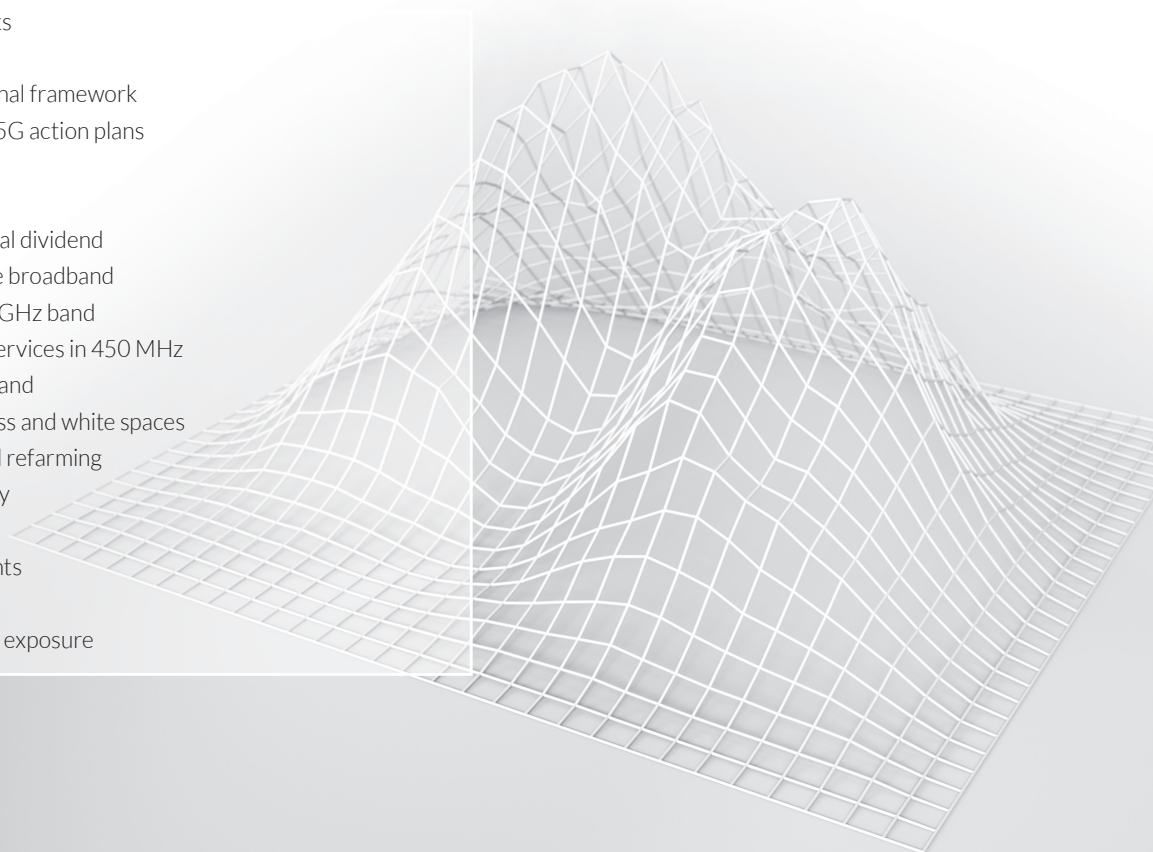

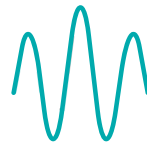
Mobile operators are acquiring more spectrum to deploy 4G and 5G networks and to satisfy the ever-increasing demand for mobile broadband services.
